

Inspiring a Love of Reading with Dolly Parton's Imagination Library

Dolly Parton's Imagination Library delivers free, high-quality, age-appropriate books to children under five to help them build home libraries, promote family bonding time, and inspire a love for reading that will last a lifetime. During the 22-23 program year, we enrolled 452 children and helped to distribute 3,529 books across Reno/Sparks, Carson City, Churchill County, Elko County, Douglas County, Humboldt County, and Lyon County.

Improving Grade-Level Reading with United Readers

United Readers experienced significant growth in its third year, with 17 highly trained Ameri-Corps mentors dedicated to helping students build foundational literacy skills. Using a research-based curriculum, mentors provided one-on-one and small group instruction to 324 students across seven schools. On average, each student received almost 12 hours of individualized intervention time. In the final analysis, 95% of students demonstrated improvement after participating in the United Readers program.

Providing High-Quality Early Education with Nevada Ready! Pre-K

We partnered with the Nevada Department of Education and United Way of Southern Nevada to provide free, high-quality State Pre-K for children who would otherwise not have access. Over the 2022-2023 school year, we collaborated with 14 early learning centers to offer exceptional early education to 150 four-year-olds across five counties, including Lyon, Douglas, Elko, Washoe and Carson.

Bridging the Gap with Ride United: Last Mile Delivery

Through Ride United: Last Mile Delivery, we connect transportation limited folks in need with food and essential items at no charge to them. We partnered with eight area agencies and DoorDash's Project DASH to complete over 6,000 deliveries in Carson City, Douglas County, Elko County, Lyon (Fernley), and Washoe county.





